Waiver of Liability and Indemnity Agreement

I, _____, hereby acknowledge, understand and agree that I am voluntarily participating in the Stanislaus Sheriff's K9 Association and the Western States Police Canine Association Canine Trials on October 2-3, 2009.

Waiver: On behalf of myself, my heirs, executors, administrators, personal representatives, or assignees, I do hereby release, waive, discharge, and covenant not to sue the County of Stanislaus, Stanislaus County Sheriff's Department, Stanislaus Sheriff's K9 Association and the Western States Police Canine Association its members, owners, officers, employees, volunteers, and agents, from liability from any and all claims arising from this event.

This agreement applies to 1) personal injury (including death) from accidents or illnesses arising directly or indirectly from my voluntary participation; and to 2) any and all claims resulting from the damage to, loss of, or theft of property.

Indemnification and Hold Harmless: I also agree to hold harmless and indemnify the County of Stanislaus, Stanislaus County Sheriff's Department, Stanislaus Sheriff's K9 Association and the Western States Police Canine Association its members, owners, officers, employees, volunteers, agents, and insurance carriers from all claims (whether initiated by me or by a third party) and to reimburse them for any expenses incurred as a result of my involvement with the event. I further agree to pay all expenses, including court costs and attorneys' fees, incurred by the County and the aforementioned parties in investigating and defending a claim or suit resulting from my voluntary participation in this event.

Severability and Venue: I further expressly agree that the foregoing waiver and assumption of risk agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Likewise, I agree that if legal action is brought, it must be brought in the District Court or the Federal Court residing where the incident occurred.

Acknowledgment of Understanding. I have had sufficient opportunity to read this waiver of liability and indemnification agreement and fully understand its terms. I understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend my signature to be a complete and unconditional release of all liability for injury resulting from ordinary negligence to the greatest extent allowed by law in the State of California.
