We are also about to enter a new phase for WSPCA in the creation of our own certification for narcotic canines. We will be putting together a committee to establish guidelines and standards for certification. We will also be trying to establish some dialogue with POST to look at standards for certification.

The K9 memorial at U.C. Davis is currently being updated and WSPCA is the primary association responsible for its maintenance. The memorial will be held on the last Tuesday of March 2009 during the noon hour. This date is tentative pending availability of key note speakers, but we will need sponsors to help with cost for name plates and reception that will follow. This is another way we become more active as an association.
